

## HIGHWAYS ACT, 1959

*M5 Motorway (Bathpool—Blackbrook Footpath Diversion) Order 1971*

The Secretary of State for the Environment hereby gives notice that, in relation to the part of the M5 Motorway which will be situated between Bathpool and Blackbrook in the county of Somerset, he has made an Order under sections 13 and 18 of the above Act, the effect of which is:

- (a) to authorise him:
- (i) to stop up highways
  - (ii) to construct a new highway, and
  - (iii) to provide new means of access to premises,
- all on or in the vicinity of the route of the above-mentioned part of the said Motorway, and
- (b) to provide for the transfer of the said new highway to the County Council of Somerset as from the date on which he notifies that Council that the new highway is open for public use.

Copies of the Order and of the relevant plan have been deposited at the Department of the Environment, 2 Marsham Street, London S.W.1, and at the offices of the South Western Road Construction Unit, 26B Fore Street, Taunton, Somerset; Somerset C.C., County Hall, Taunton; Taunton R.D.C., Mary Street House, Mary Street, Taunton; and of the Divisional Road Engineer, Government Buildings, Alphington Road, Exeter, Devon, where they are open to inspection free of charge at all reasonable hours.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959 or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may within six weeks from 28th September 1971 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

## HIGHWAYS ACT, 1959

*The Ipswich—Weedon Trunk Road (Stowmarket to Claydon By-Pass) Order 1971*

The Secretary of State for the Environment hereby gives notice that he has made an Order under sections 7, 44 and 286 of the above Act providing:

- (a) that the roads which he proposes to construct between Stowmarket and Claydon in the county of East Suffolk shall become trunk roads as from the date when the Order comes into operation, and
- (b) that the lengths of the Ipswich—Weedon Trunk Road (A.45) to be superseded shall cease to be trunk road as from the 1st April next after the date on which notice is given by the Secretary of State to the County Council of East Suffolk (who will become the highway authority responsible for those lengths) that the new trunk roads are open for through traffic.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act, 1959 or on the ground that any requirement of that Act, or of regulation made thereunder, has not been complied with in relation to the Order, may, within six weeks from 1st October 1971, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
