

generation of electricity at the Central Electricity Generating Board's Bankside generating station for the purpose of heating buildings in the area to which this Scheme applies:

1. *Area of Operation*

The area to which the Scheme applies is an area within the London Borough of Southwark bounded by the River Thames on the north; by Waterloo Bridge on the west; by and including Stamford Street, Southwark Street, St. Thomas Street, Joiner Street and Tooley Street on the south and by and including St. Saviour Dock on the east.

2. *Source of Heat*

Heat obtained from or in connection with the generation of electricity at Bankside generating station, supplemented from the London Electricity Board's resources, will be used for the heating of buildings in the said area.

3. *Adaptation*

The heat obtained from Bankside generating station will be primary steam at high pressure which will be passed through heat exchangers to provide hot water at low pressure and at a temperature suitable for circulation to and use in buildings in the said area.

4. *Method of Supply*

The heat will be circulated in the said area by way of large diameter pipes containing pipes for the conveyance of heat and thermal insulation mechanically protected all in accordance with technical practices current from time to time. Where such pipes have to be accommodated in or under streets they will be placed at depths and in positions having due regard to the support of the surface of the streets and the safeguarding of statutory undertakers' apparatus.
