## Y SWYDDFA GYMREIG

*The Trunk Road (Newbridge Road, Newbridge)*  
(Restriction of Waiting) Order 1971

Notice is hereby given that the Secretary of State intends to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to restrict waiting between the hours

of 7 a.m. and 7 p.m. in that length of the Swansea—Manchester Trunk Road (A.483), known as Newbridge Road at Newbridge in the County of Denbigh, which extends from a point 49 yards south of its junction with Park Road in a general south-easterly direction to the eastern side of New Bridge (otherwise known as Dee Bridge), a distance of approximately 954 yards.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as it may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.

## Y SWYDDFA GYMREIG

*The Trunk Road (Various Streets, Ruthin) (Restriction of Waiting) Order, 1971*

Notice is hereby given that the Secretary of State for Wales intends to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to revoke The County of Denbigh (Traffic Regulation) Order 1952, The Trunk Road (Well Street, Ruthin) (Prohibition of Waiting) Order 1962 and The Trunk Road (Castle Street, Ruthin) (Restriction of Waiting) Order 1967; and to prohibit waiting between the hours of 8 a.m. and 6 p.m.:

1. in any of the lengths of road or on the side of road, specified in Schedule 1 to this notice; or
2. on the side of road specified in Schedule 2 to this notice:
  - (a) for a longer period than 30 minutes, or
  - (b) if a period of less than 30 minutes has elapsed since the termination of the last period of waiting (if any) of the vehicle on that side of road during the said hours.

Exemptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.

Exemptions will also be provided in the Order to enable a vehicle to wait in that side of road specified in Schedule 2 below if that vehicle is an invalid carriage; a vehicle which has been issued to a disabled person by the Government in lieu of an invalid carriage; or a vehicle which bears at the front and rear in conspicuous positions yellow badges issued to the driver in pursuance of a scheme under either section 29 of the National Assistance Act 1948 or section 21 of the Chronically Sick and Disabled Persons Act 1970.
