HIGHWAYS ACT 1959

The M4 Motorway (Capel Llanilltern to Pencoed Section) and Connecting Roads (Side Roads) Order 1971.

The Secretary of State hereby gives notice that he proposes to make an Order under section 13 of the above Act which will:

(a) authorise him:

- (i) to improve, raise, lower or otherwise alter highways,
- (ii) to stop up highways,
- (iii) to construct new highways,
- (iv) to stop up private means of access to premises, and
- (v) to provide new means of access to premises all on or in the vicinity of the above-mentioned special roads, and

(b) provide for the transfer of each of the said new highways to the County Council of Glamorgan as from the 1st April next after the date on which the Secretary of State notifies that authority that the new highways have been completed and are open for through traffic.
