- (d) to a vehicle being used for the purpose of delivery or collecting postal packets;
- (e) to a vehicle being used by or on behalf of a local authority for the purpose of collecting household refuse or clearing cesspools;
- (f) to a vehicle waiting while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait elsewhere; and
- (g) to a vehicle waiting in any case where the person in control of it:
 - (i) is required by law to stop;
 - (ii) is obliged to stop to avoid an accident; or
 - (iii) is prevented from proceeding by circumstances outside his control and cannot re-move the vehicle from the main carriageway.

The Secretary of State for the Environment has made The Secretary of State for the Environment has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit north-bound traffic in that length of the Swansea—Manchester Trunk Road (A.56), known as Chester Road in the Borough of Stretford, from making a right-hand turn so as to enter Edge Lane in the said Borough said Borough.

An alternative route for north-bound traffic wishing to enter Edge Lane is available via Barton Road, and King Street.

The Trunk Road (Wellington Street, Crown Lane and High Street, Littleport) (Prohibition and Restriction of Waiting) Order 1971.

The Secretary of State for the Environment proposes to make an Order under sections I and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The effect of this Order will be to replace existing

restrictions on the waiting of vehicles on those lengths of the London—Cambridge—King's Lynn Trunk Road (A.10) specified in the Schedule to this Notice so that waiting will now be prohibited at all times.

Existing restrictions on the remainder of Crown Lane and High Street and Wellington Street will remain unchanged.

Exceptions will be provided in the Order to enable

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.
