The Borough of Bury St. Edmunds (Various Streets) (Prohibition and Restriction of Waiting; Prohibition of entry for Heavy Vehicles; Prohibition of Driving and One Way Traffic) (No. 3) Order, 1971.

Notice is hereby given that on the 4th November 1971 the Bury St. Edmunds Borough Council made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, to provide for traffic regulation in the undermentioned streets as follows:

(a) No waiting at any time in parts of Blomfield Street, King's Road, Mill Road, Prospect Row and Westley Road, Bury St. Edmunds;

(b) No waiting between the hours of 8 a.m. and 6 o.m. in parts of Cannon Street and Honey Hill, Bury St. Edmunds;

- (c) The prohibition of vehicles with a weight, whether laden or unladen, in excess of 3 tons, from entering Brentgovel Street from the St. Andrew's Street/Risbygate Street junction; and Woolhall Street from St. Andrew's Street South, except when necessary for the purpose of gaining access to premises in certain streets named in the Order;
- (d) The prohibition of the driving of any vehicle in any of the roads within the area known as the Cathedral Churchyard, with the exception of the access road from Honey Hill to the Shire Hall Car Park; and
- (e) One way traffic in a westerly direction only in the unnamed road along the north side of the Norman Tower.

The effect of the proposals in (c), (d) and (e) above is merely to make permanent the existing experimental traffic regulations already in operation.

Exceptions to the waiting restrictions referred to in (a) and (b) above willy permit waiting for the following purposes:

(i) picking up or setting down passengers;
(ii) loading or unloading goods;
(iii) delivery and collection of postal packets;
(iv) carrying out essential services connected with the maintenance of the road and the supply of gas, water and electricity; and
(v) to enable a vehicle to take in petrol, oil, water

or air.

Exemptions from the prohibition referred to in (d) above will permit driving in the Cathedral Churchyard:

(a) to enable access to be obtained to premises accessible only from the Cathedral Churchyard;

(b) for the carrying out of essential services con-

nected with the maintenance of the road and the supply of gas, water and electricity; and (c) for fire brigade or ambulance service purposes, and for local authority or police purposes in pursuance of statutory powers or duties.

There will also be an exemption to the prohibition referred to in (d) above to permit cycling along the western-most diagonal roadway in the Cathedral Churchyard between Honey Hill and the Norman Tower.
