Notice is hereby given that the Huntingdon and Peterborough County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit, subject to statutory exemptions:

- (a) The waiting of vehicles in the road and lengths of road specified in the First Schedule to this notice, and
- (b) The waiting of vehicles for periods exceeding 40 minutes in any hour between 8 a.m. and 6 p.m. in the lengths of road specified in the Second Schedule to this notice.

*Road and Lengths of Road in the Urban District of  
St. Neots*

South Street.  
Brook Street.

*On its northern side*

- (i) From a point approximately 11 yards from its junction with St. Marys Street in a westerly direction for approximately 113 yards.
- (ii) From a point approximately 136 yards from its junction with St. Marys Street in a westerly direction for approximately 8 yards.
- (iii) From a point approximately 158 yards from its junction with St. Marys Street to its junction with South Street.

*On its southern side*

- (i) From a point approximately 11 yards from its junction with St. Marys Street in a westerly direction for approximately 46 yards.
- (ii) From a point approximately 61 yards from its junction with St. Marys Street to its junction with South Street.

SECOND SCHEDULE

*Lengths of Road in the Urban District of St. Neots  
Brook Street.*

*On its northern side*

- (i) From a point approximately 113 yards from its junction with St. Marys Street in a westerly direction for approximately 23 yards.
- (ii) From a point approximately 144 yards from its junction with St. Marys Street in a westerly direction for approximately 14 yards.
