Notice is hereby given that the above-named Order made on the 29th October 1971 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed, as an unopposed Order, by the Gipping Rural District Council

The effect of the Order if confirmed without modification will be to divert that part of Footpath No. 38 which commences at a point approximately 330 yards south-east of Darmsden Lane, Barking (being a track leading to Robuck Farm) and runs first in a south-westenly direction and then in a southerly direction to the western corner of Chalkpit Wood for a distance of approximately 217 yards.
