- Saturdays inclusive in the lengths of streets described in Schedule 2 to this notice;
 (ii) and additionally between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive for a period exceeding 20 minutes in any of the lengths of streets referred to in Schedule 1 to this notice which would not otherwise be subject to such a prohibition during these times: during these times;
- vehicle would be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Harrow Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
- (d) the use of any vehicles or of any animal or the wearing of fancy dress or other costume wholly or mainly for the purpose of advertising would be prohibited; and

- (b) The existing prohibition on waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle between the hours of 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive which apply in the length of Kenton Lane described in Schedule 3 to this notice by virtue of the Harrow (Waiting and Loading Restriction) Order 1971 will be revoked.

The prohibitions referred to in paragraph 2 above would not apply in relation to vehicles waiting:

- (a) for the purpose of picking up or setting down passengers ;
