

Transport Act 1968, the effect of which is to prohibit the waiting by vehicles at all times in Victoria Road, Hartshill, from its junction with the Trunk Road A.47 north-westwards for a distance of 32 metres. The Order will come into force on Friday the 19th November, at the same time, as other Orders, made by the Department of the Environment and the Nuneaton Borough Council respectively, prohibiting waiting at the approaches to the cross roads where Victoria Road meets Coleshill Road, Camp Hill and Bucks Hill.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, to enable Post Office vehicles to deliver or collect mail and to enable the vehicle to be used in pursuance of statutory powers or duties.

A copy of the Order, together with a map showing the length of road affected may be inspected at the office of the Clerk of the Council, Shire Hall, Warwick, on Mondays to Fridays inclusive, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may within 6 weeks from the 5th November 1971, apply to the High Court for this purpose.

(Powell Street) (One-Way) Order 1971*

WILTSHIRE COUNTY COUNCIL

The County of Wilts (Bell's Lane, U/C. 9108, Zeals) (Weight Restriction) Order, 1971

Notice is hereby given that on the 10th November 1971, the Wiltshire County Council made an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which will be to prohibit any person to drive or cause or permit to be driven any vehicle, the unladen weight of which exceeds 3 tons, in Bell's Lane, U/C 9108, Zeals, from its junction with the trunk road A.303 in a northerly direction to its junction with Bayleys Lane (C.278).

The usual exceptions have been included so as to permit a vehicle to be used for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the length of road and having access therefrom or to gain access to such premises.
