## DEPARTMENT OF THE ENVIRONMENT

TOWN AND COUNTRY PLANNING ACTS  
1962 AND 1968

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 153 of the Town and Country Planning Act 1962 entitled "The Stopping up of Highways (City and County Borough of Liverpool) (No. 11) Order 1971" authorising the stopping up of a length of Alt Street and adjoining and adjacent passageways at Liverpool.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Acts or that any requirement of those Acts or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 16th November 1971, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

TOWN AND COUNTRY PLANNING ACTS  
1962 AND 1968

1962 AND 1968

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 153 of the Town and Country Planning Act 1962 entitled "The Stopping up of Highways (City and County of Norwich) (No. 1) Order 1971" authorising the stopping up of the whole length of Burnaby Road and parts of Goldwell Road, Gordon Road and an unnamed footpath leading from Chapel Alley to Hall Road, Norwich and requiring the provision of new highways.
