

ALTRINCHAM BOROUGH COUNCIL

The Altrincham Corporation (Delamer Road, The Downs, St. John's Road) (Prohibition and Restriction of Waiting) Order 1972.

Notice is hereby given that the Altrincham Borough Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to:

- (1) Prohibit waiting by vehicles at any time on the sides of lengths of roads shown in Schedule 1 hereto.
- (2) Prohibit waiting by vehicles between the hours of 9 a.m. and 6 p.m. on any day other than a Sunday, on the sides of lengths of roads shown in Schedule 2 hereto.

Exceptions will be provided in the Order to permit waiting for the purposes of boarding, alighting, loading and unloading and for funerals, building and road works and the maintenance of essential services.

A copy of the proposed Order and a map showing the sides of lengths of roads to which the proposed Order relates, may be inspected at the offices of the undersigned during normal office hours.

Objections to the proposals, together with the grounds on which they are made, must be sent in writing to the undersigned by the 31st December 1971.

SCHEDULE 1

The Downs. Southerly side "No Waiting" at any time from its junction with Delamer Road to its junction with St. John's Road.

St. John's Road. Northerly side "No Waiting" at any time from its junction with The Downs in an easterly direction to a point 50 feet from its junction with Delamer Road.

SCHEDULE 2

Delamer Road. South-easterly side "No Waiting" between 9 a.m. and 6 p.m. on Monday to Saturday inclusive from its junction with The Downs for a distance of 90 feet in a south-westerly direction.

Northerly side "No Waiting" between 9 a.m. and 6 p.m. on Monday to Saturday inclusive from its junction with Wellington Place for a distance of 51 feet in a westerly direction.

Northerly side "No Waiting" between 9 a.m. and 6 p.m. on Monday to Saturday inclusive from its junction with Wellington Place for a distance of 60 feet in an easterly direction.

Northerly side "No Waiting" between 9 a.m. and 6 p.m. on Monday to Saturday inclusive from its junction with New Street for a distance of 60 feet in a westerly direction.

Northerly side "No Waiting" between 9 a.m. and 6 p.m. on Monday to Saturday inclusive from its junction with New Street for a distance of 60 feet in an easterly direction. (295)

BARNSELY COUNTY BOROUGH COUNCIL

The County Borough of Barnsley (Greenfoot Lane) (Restriction of Waiting) Order 1971

Notice is hereby given that on the 23rd day of November 1971, the Barnsley County Borough Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968.

The Order comes into effect on the 29th November 1971, when it will be unlawful to cause any vehicle to wait between the hours of 8.30 a.m. and 4.30 p.m. on Mondays to Fridays in that part of Greenfoot Lane which extends from a point 46 metres from its junction with Huddersfield Road to a point 76 metres from its junction with Wilthorpe Avenue a distance of approximately 139 metres.

There are the usual exceptions in the Order to permit persons to board or alight from vehicles, to load or unload vehicles and to enable vehicles to be used in connection with building operations, funerals, weddings, etc.

A copy of the Order and a map showing the road affected may be examined at the Town Clerk's Department, Town Hall, Barnsley, during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967 (as amended) or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, may, within 6 weeks from the date on which the Order was made, make application for that purpose to the High Court.

BERKSHIRE COUNTY COUNCIL

Royal County of Berkshire (Twyford) (Prohibition and Restriction of Waiting) Order, 1971

Notice is hereby given that the Berkshire County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

When this Order comes into effect you will not be allowed to leave your vehicle at any time in those lengths of road specified in Schedule 1 at any time between the hours of 8 a.m. to 6 p.m. in those lengths of road specified in Schedule II, and only for 1 hour in any 2 hours in those lengths of road specified in Schedule III to this notice.

Exceptions will permit waiting for the purposes of:

- (a) picking up and setting down passengers.
- (b) loading and unloading goods and, where necessary in connection with:
- (c) the maintenance of the road, and
- (d) the supply of gas, electricity, water and other services.

Full details of these proposals are in the draft Order which together with a map showing the restricted areas and a statement of the Council's reasons for proposing to make the Order, may be examined at:

SCHEDULE 1

To prohibit waiting at any time on the following lengths of road:

- (a) A.321 Waltham Road (both sides) from its junction with Hurst Road north-westwards to its junction with Station Road, a distance of approximately 360 metres.
- (b) Springfield Park (both sides) from its junction with Waltham Road in a north-easterly direction for a distance of approximately 50 metres.

SCHEDULE II

To prohibit waiting between the hours of 8 a.m. and 6 p.m. on the following lengths of road Mondays to Saturdays inclusive:

- (a) Station Road (south-west side) from its junction with Waltham Road south-eastwards for a distance of approximately 170 metres.
- (b) Station Road (north-east side) from its junction with Waltham Road south-eastwards for a distance of approximately 28 metres.
- (c) Station Road (north-east side) from a point approximately 128 metres south-east of its junction with Waltham Road south-eastwards for a distance of approximately 60 metres to its junction with Station Terrace.
- (d) Station Terrace (south-east side) from its junction with Waltham Road to its junction with Gas Lane.
- (e) Station Terrace (north-west side) from its junction with Station Road north-eastwards for a distance of approximately 51 metres.
