To prohibit waiting, loading and unloading, at any time, on the following lengths of road:

(a) Church Road, both sides, from its junction with The Forty, for a distance of approximately 15 metres (16 yards approx.) in a north-westerly direction.

(b) Wallingford Road, both sides, from a point approximately 90 metres (98 yards approx.) south-west of its junction with Cross Road to its junction with The Forty.

(c) The Forty, both sides, from its junction with Church Road and Wallingford Road for a distance of approximately 30 metres (33 yards approx.) and on both sides from a point level with the northern edge of the green adjacent to the bus shelter, for a distance of approximately 28 metres (31 yards approx.) in a southerly direction.

(d) Ilges Lane, from its junction with The Forty for a distance of approximately 15 metres (16 yards approx.) on its north side and approximately 18 metres (20 yards approx.) on its south side, in an easterly direction.

(e) The Forty, Station Road and Honey Lane at the junction of those three roads, from a point in Honey Lane adjacent to the south-east boundary of No. 1 Station Road, in a north-westerly, westerly and south-westerly direction into Station Road, a distance of approximately 32 metres (35 yards approx.).

To prohibit waiting, loading and unloading between the hours of 8 a.m. and 6 p.m. on any day.
