PRESENT.

The QUEEN'S Most Excellent Majesty in Council Her Majesty, in exercise of the powers conferred on Her by section 3 of the Naval and Marine Pay and Pensions Act 1865 (28 and 29 Vict. c. 73), and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order and it is hereby ordered as follows: to order, and it is hereby ordered, as follows:

Citation 1. This Order may be cited as the Naval Medical and Dental Officers' (Professional Pay) (Amendment) Order 1971.

Interpretation
2. The Interpretation Act 1889 (52 and 53 Vict. c. 63) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The Naval Medical and Dental Officers' (Professional Pay) Order 1969 shall be amended by deleting in paragraph 3 (Diploma Pay) of the Schedule thereto the words from "Subject to" to "following diplomas" and substituting the following:

"Subject to any instruction issued by the Defence Council, Diploma Pay shall be payable at the rate of £0:30 a day to Non-Specialist Medical Officers below the rank of Surgeon Captain if they are Members of the Royal College of General Practitioners, or hold the degree qualification of Master of Science in Occupational Medicine, or are in possession of one of the following diplomas:—"
