### WAGES COUNCILS ACT 1959

#### *Retail Food Trades Wages Council (England and Wales)*

The Retail Food Trades Wages Council (England and Wales) hereby gives notice of its intention to submit to the Secretary of State for Employment proposals for (1) varying the statutory minimum remuneration set out in the Wages Regulation (Retail Food) (England and Wales) Order 1971 (Order R.F.C.(53)); and (2) amending the provisions relating to holidays and holiday remuneration.

Particulars of the proposals are contained in the Wages Council's Notice R.F.C.(54) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 14 days from 30th November 1971. Any such representation should bear the writer's address and signature and be sent to the Secretary, Retail Food Trades Wages Council
