Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 24th November 1971, is about to be submitted to the Secretary of State for Wales for confirmation or to be confirmed by the County Council of the Administrative County of Monmouth as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way F.P. No. 75 running across land in the Parish of Rogerstone and more particularly described in the Schedule hereto.

##### PART I

###### *Description of Existing Path*

That length of footpath No. 75 which runs from County Highway No. S.85-1 in a south-easterly direction for a distance of 420 yards or thereabouts and thence in a south-westerly direction for a distance of 50 yards or thereabouts and it then runs in a south-easterly direction for a distance of 386 yards or thereabouts and thence in a north-easterly direction for a distance of 56 yards or thereabouts and thence in a south-easterly direction for a distance of 50 yards or thereabouts and thence in an easterly direction to join County Highway No. C.87-11 for a distance of 60 yards or thereabouts and as shown by a bold red line and marked a—b on the map annexed to the Order.
