BOLTON COUNTY BOROUGH COUNCIL CLEAN AIR ACT 1956

The Bolton (East and West Wards) Smoke Control Order 1972

Subject to the exemptions provided by virtue of Section 11(4) of the Act and by the Order if on any day after this Order has come into operation smoke is emitted from a chimney of any building within the Smoke Control Area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

ROAD TRAFFIC ACTS

DERBY COUNTY BOROUGH COUNCIL

The County Borough of Derby (Derwent Street) (Restriction of Waiting) Order 1972

Notice is hereby given that the Council of the County Borough of Derby propose to make an Order under Section 1(1), (2), and (3), of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968.

The effect of this Order will be to impose waiting restrictions in Derwent Street as follows:

(a) waiting will be prohibited at any time in the following lengths:

- (i) the west side from its junction with Full Street to its junction with Stuart Street
- (ii) The west side from distances of 45 feet in both directions from its junction with Phoenix Street
- (iii) The east side from its junction with Corporation Street to a point 45 feet north of its junction with Exeter Place
- (iv) the east side from its junction with Exeter Street for a distance of 163 feet in a southerly direction

(b) waiting will be limited to one hour in any two hours between 8.00 a.m. and 6.00 p.m. in the following lengths:

- (i) the west side from its junction with Stuart Street to a point 45 feet south of its junction with Phoenix Street
- (ii) the west side from a point 45 feet north of its junction with Phoenix Street to its junction with the slip road to the Inner Ring Road
- (iii) the east side from a point 45 feet north of its junction with Exeter Place to a point 163 feet south of its junction with Exeter Street.

(c) Exceptions to these waiting restrictions will permit waiting where necessary for the purposes of picking up and setting down passengers, loading and unloading goods and carrying out certain essential services. The Limited waiting restrictions will not apply to a disabled person's vehicle which displays a disabled person's badge. Previous restrictions on the lengths of road affected by this Order will be revoked.

Full details of the proposals are in the draft Order which together with a map showing the road affected and a statement of the Council's reasons for proposing to make the Order may be examined at the offices of the undersigned from 9.00 a.m. to 1.00 p.m. and from 2.00 p.m. to 5.30 p.m. Mondays to Fridays.
