THE IMPORTATION OF CARCASSES AND ANIMAL
PRODUCTS ORDER 1972
(made 29 February 1972)

This order, which comes into operation on 1 May 1972, revokes and replaces with modifications the Importation of Carcasses and Animal Products Order 1954 as amended. The order prohibits the import into Great Britain of animal carcasses (including parts of such carcasses) and animal products to which the order applies except in accordance with the terms of a licence issued by the Minister of Agriculture, Fisheries and Food or the Secretary of State for Scotland. The order applies to the carcasses of the following animals, namely, horses, asses, mules and pigs, and cattle, sheep, goats and other ruminating animals and to any products derived from such animals with the exception of the carcasses and animal products listed in Schedule 1 to the order.
