- (a) were members of the Territorial and Army Volunteer Reserve, the Army Emergency Reserve of Officers, the Territorial Army or the Terri-torial Army Reserve of Officers, and
- (b) who transferred to the Regular Army Reserve of Officers, and
- (c) who attained the age limit of their rank and Corps on a date during the period 1st Jan. 1972 to 31st Mar. 1972,

will cease to belong to the Regular Army Reserve of Officers on that date.
