SOLIHULL COUNTY BOROUGH COUNCIL *The County Borough of Solihull (Prohibition of Cycling) No. 4 Order, 1972*

LIVERPOOL CITY COUNCIL
*The City Council of Liverpool (Aigburth Road/
 St. Mary's Road Etc.) (Prohibition and Restriction
 of Waiting) Order 1972*

Notice is hereby given that the City Council of Liverpool proposes to make an Order under sections 1(1), (2) and (3) and 84D(1) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which will be:—

1. To revoke the Orders specified in Column 1 of Schedule 5 to this Notice in the extent specified in Column 2 of the said Schedule;
2. To prohibit, with certain exceptions, the waiting by vehicles:—
 - (a) at any time in any of the roads or lengths of roads specified in Schedule 1 to this Notice;
 - (b) between 7 a.m. and 7 p.m. on Mondays to Saturdays inclusive in any of the roads or lengths of roads specified in Schedule 2 to this Notice;
 - (c) for more than 1 hour in any period of 2 hours between 7 a.m. and 7 p.m. on Mondays to Saturdays inclusive in any of the roads or lengths of roads specified in Schedule 3 to this Notice;

The exceptions referred to in the fore going Order will enable a vehicle to wait for so long as is necessary

(a) for a person to board or alight from the vehicle, (b) to enable the vehicle to be used in connection with any wedding, funeral, building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, (c) to enable the vehicle to take in petrol, oil, water, or air from any garage situated on or adjacent to the said lengths of road, and (d) to enable goods to be loaded on to or unloaded from the vehicle, provided that no vehicle (other than a vehicle being used for the purposes of delivering or collecting postal packets as defined in section 87 of the Post Office Act, 1953) shall so wait between the hours of 8.00 a.m. and 9.30 a.m. and 4.30 p.m. and 6.00 p.m. on Mondays to Saturdays inclusive in any of the roads or lengths of roads specified in Schedule 4 to this Notice.

A copy of the proposed Order, the relevant plan, and a statement of the Council's reasons for proposing to make the Order, may be inspected at the Town Clerk's Office, Legal and Parliamentary Section, Room 214, Municipal Buildings, Dale Street, Liverpool, between the hours of 8.30 a.m. and 4.45 p.m. on Mondays to Fridays inclusive.
