THE CLEAN AIR ACT, 1956

*The Spenborough No. 13 (Hartshead/Roberttown/Norristhorpe) Smoke Control Order, 1972*

Notice is hereby given that the Spenborough Borough Council in exercise of the powers conferred on them by Section 11 of the above-mentioned Act on the 10th May 1972, made an Order entitled The Spenborough No. 13 (Hartshead/Roberttown/Norristhorpe) Smoke Control Order 1972 declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State, Department of the Environment for confirmation.

Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding Ten Pounds unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before 1st July 1973 or before a later date determined by the Secretary of State, Department of the Environment.

Copies of the Order and of the Map referred to therein may be inspected free of charge at the Town Clerk's Office, Spenborough Town Hall, Cleckheaton, at all reasonable times during the period of six weeks from 19th May 1972.
