TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 30th June 1972, at 1 p.m. for Treasury Bills to be issued under the Treasury Bill Act, 1877, and the National Loans Act, 1968, to the amount of £80,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, 3rd July 1972, to Friday the 7th July 1972, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received, to the person whose Tenders are accepted in whole or in part. Payments in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

ROYAL WARRANT

Whereas We deem it expedient to make further provision concerning the pensions and associated benefits for certain members of the former Indian and Burma Armed Forces specified in the Fourth Schedule to Our Warrant of 21st May 1955; and to make provision concerning the pensions and associated benefits for certain members of the former Indian Armed Forces for whose pensions Her Majesty's Government assumed responsibility under the Pensions (India, Pakistan and Burma) Act 1955 (3 & 4 Eliz. 2, c. 22).

Our Will and Pleasure is that:

There shall be applied to the persons referred to in the Fourth Schedule to Our Warrant of 21st May 1955, and to officers and soldiers of the former Indian Armed Forces, to members of the Women's Auxiliary Corps (India) and to members of the Indian Military Nursing Service, and to their widows and dependants, for whose pensions Her Majesty's Government assumed responsibility under the Pensions (India, Pakistan and Burma) Act 1955:

(a) the improvements in disability awards and connected allowances and in widows' and dependants' pensions and connected allowances authorised for members of the corresponding Armed Forces of the United Kingdom and for their widows and dependants in Our Warrant of 16th July 1971 (Cmnd. 4742);

(b) the other provisions of Our Warrant of 16th July 1971, as the said improvements and other provisions apply to or in respect of the persons referred to in Our Warrant of 16th July 1971.

2. Any benefit granted under this Our Warrant may be withheld or reduced if the officer, his widow or children, are in receipt of any overlapping awards from the Department of Health and Social Security by the amount of any such awards.

Town and Country Planning Act, 1971

The Secretary of State for Wales hereby gives notice that he has made an Order under section 209 of the Town and Country Planning Act, 1971, to authorise the stopping up of that length of Bryn Road, Wrexham Industrial Estate in the County of Denbigh which extends from a point 176 yards south of its junction with Ridley Wood Road in a southerly direction for a distance of 1,024 yards to enable development consisting of a factory complex to be carried out in accordance with planning permission granted by Denbighshire County Council.

The Order requires the provision of a new highway maintainable at the public expense, for which the highway authority is to be the Denbighshire County Council.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 23rd June 1972, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
