Town and Country Planning Act 1971

The Secretary of State hereby gives notice that he has made an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of that length of Field Street at Cefn Coed-y-Cymmer, Breconshire, which extends from a point 25 yards from its junction with Pont-y-Capel Road in a south-easterly direction for a distance of 125 yards to enable residential development to be carried out in accordance with planning permission granted under Part III of that Act.
