The authorised fuels include anthracite coke and other carbonised ised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before 1st June 1974, or before a later date determined under the provisions of the Clean Air Act 1956.

After the Order has been confirmed, such persons should, before any work is carried out or any expenditure incurred, submit their proposals to the Clean Air Section of the Health

Department in the Town Hall Extension, Manchester.
The parts of the proposed smoke control area coloured pink on the map referred to in paragraph 4 above will be surveyed in 1972-73 or thereabouts for action under Part III of the Housing Act 1957. As the Smoke Control Order does not prohibit the emission of smoke from premises in those parts of the smoke control area coloured pink on the map the grant referred to in paragraph 6 will not be pay-able in respect of dwellings in those parts of the smoke control area.

If the Order is confirmed, notices of confirmation will be published in the Press and copies of the notice

posted in the smoke control area.

The area to which the Order relates is situated in the Moston area of the City of Manchester and is bounded on the north and east by the City boundary; on the south by the British Railways line from Manchester to Oldham, Dean Lane, St. Mary's Road, Joyce Street and Kenyon Lane; and on the west by Moston Lane and Greengate.
