The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under section 1 of the Finance Act 1971, viz:

This Order, which comes into operation on 1st January 1973:

- (1) extends, until 1st January 1974, the operation of the Import Duties (Developing Countries) Order 1971 which implemented the Generalised System of Preferences;
- (2) provides for certain additional countries to be included among the developing countries whose goods are eligible for relief from import duties chargeable under the Import Duties Act 1958 and nominates approved ports of consignment where appropriate.

The Order comes into operation on 1st January 1973, and has been published as Statutory Instruments 1972 No. 1791.
