

The effect of the Order, as confirmed is to divert that section of public footpath No. 20 in the Urban District of Buckley which commences at the stile at the north-westerly end of Colliers Lane, Pren Hill, Mynydd Isa and extends in a north-westerly direction to a point 272 metres or thereabouts further on to a different line of approximately 308 metres distance running between the same points, and within the Rural District of Holywell.

A copy of the confirmed Order and the map contained in it has been deposited at the Rural Council Offices, Halkyn Road, Holywell, and may be inspected free of charge at the Council Offices between the hours of 9 a.m. and 5 p.m. on any weekday except Saturday.

This Order became operative on the 19th January 1973, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under Schedule 6 paragraph 3 of the Town and Country Planning Act 1971, within 6 weeks from the date of publication of the notice make application for the purpose to the High Court.

Public Path Diversion Order, 1973

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 17th day of November 1972, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the East Suffolk County Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the existing line of Bawdsey Footpath No. 2 from a point to the south-west of the Martello Tower in a north-easterly direction for a distance of approximately 66 lineal yards on to a line starting from the same point to the south-west of the Martello Tower and running in an easterly then in a northerly direction for a distance of approximately 75 lineal yards to rejoin Footpath No. 2 at a point to the north-east of the Martello Tower.
