(d) To limit the waiting of vehicles to not more than 1 hour between the hours of 8 a.m. and 6 pm . on the lengths of roads in Oundle specified in Schedule 2 to this notice.
(e) To limit the waiting of vehicles to not more than 30 minutes between the hours of $8 \mathrm{a} . \mathrm{m}$. and $6 \mathrm{p} . \mathrm{m}$. on Mondays to Saturdays on the lengths of roads in Oundle specified in Schedule 3 to this notice.
