*The Borough of Hemel Hempstead (Warners End Valley Footpath) Public Path Creation Order, 1973*

Notice is hereby given that the above-named Order, made on 9th February 1973, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed as an unopposed Order, by the Hemel Hempstead Borough Council.

The effect of the Order, if confirmed without modifications, will be to create a public footpath from the south-western end of Butts End in a generally south-westerly direction for a distance of about 180 metres to a point near the north-eastern boundary of No. 162 Spring Lane, Hemel Hempstead, including an extension from such public footpath for approximately 18 metres in a north-westerly direction to a playground known as the Warners End Valley Playground.

*The Borough of Hemel Hempstead (Piccotts End Farm) Public Path Diversion Order 1973*

Notice is hereby given that the above-named Order, made on 9th February 1973, is about to be submitted to the Secretary of State for the Environment for confirmation

or to be confirmed as an unopposed Order, by the Hemel Hempstead Borough Council.

The effect of the Order, if confirmed without modifications, will be to divert the public right of way running from a point on the western side of Piccotts End Road 36 metres or thereabouts to the north of the front entrance to Piccotts End farmhouse opposite All Saints Church in a generally westerly direction for 13 metres or thereabouts to a concrete and iron footbridge over a river bed and thence in a generally south-westerly direction for 88 metres or thereabouts to a wood and tubular steel footbridge over the River Gade and thence in a generally southerly direction for 19 metres or thereabouts to a steel double gate abutting the eastern boundary of Leighton Buzzard Road (B.486) to a line running from a point on the western side of Piccotts End Road 122 metres or thereabouts to the north of the front entrance to Piccotts End farmhouse aforesaid in a generally west-south-westerly direction for 55 metres or thereabouts to a new footbridge to be provided over the River Gade and thence in the same direction as before for 14 metres or thereabouts to a new gate at a point abutting the eastern boundary of Leighton Buzzard Road (B.486).

##### NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

HIGHWAYS ACT, 1959

*Hertford Rural District Council Little Berkhamsted No. 6 Public Path Diversion Order, 1971*

Notice is hereby given that on the 5th February 1973, the Secretary of State for the Environment confirmed with modifications the above-named Order.

The effect of the Order as confirmed is to divert the public right of way running from the drive to Stockings in a north-easterly direction for a distance of about 203 yards towards Bayford Hall to a line running from the drive to Stockings about 52 yards north of the existing path in an easterly direction for a distance of about 175 yards towards Bayford Hall.

A copy of the Order as confirmed and the map contained in it has been deposited and may be inspected free of charge at the Council Offices, between 9 a.m. and 1 p.m. and between 2 p.m. and 5.30 p.m. on Monday to Friday.

The Order becomes operative as from 5th March 1973, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act, 1959, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Order he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within six weeks from the 16th February 1973, make an application for the purpose to the High Court.
