NOTICE OF PUBLIC INQUIRY

The Trunk Road (Various Roads, Caerleon) (Weight Restriction) Order 1973

The Public Inquiry held by Mr. D. Farrar, B.Sc., F.I.C.E., F.I.Mun.E., F.R.T.P.I., M.I.H.E., F.Inst Arb., at the Town Hall, Caerleon, Newport, Mon., on Tuesday 30th January 1973, is to be reopened to consider further information concerning the proposal of the Secretary of State to make the above-named Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit motor vehicles the weight of which exceeds 20 tons, laden or unladen, to proceed in that length of the Newport-Worcester Trunk Road (A.449), known in parts as High Street, Goldcroft Common, Mill Street, Castle Street and Usk Road, at Caerleon in the County of Monmouth, which extends from the north-west abutment of Caerleon Bridge to the south-west abutment of Pont Sedwar. Eventions are provided in the Order of Pont Sadwrn. Exemptions are provided in the Order for certain vehicles.

The reconvened Inquiry, to be held by Mr. Farrar, will be at the Town Hall, Caerleon, Newport, Mon., on Friday 16th March 1973, commencing at 10 a.m. Copies of the proposed Order, plans showing the roads to which the proposed Order relates and the statement of reasons for wishing to make the Order may be inspected at the offices of the Caerleon Urban District Council, Town Hall, Caerleon, during normal office hours. Any person interested is entitled to be heard in person or by Counsel, Solicitor or agent and any person, whether he intends to appear at the Inquiry or not may forward in writing any objection to the proposals, together with the grounds on which the objection is made to the Inspec-tor, Mr. D. Farrar, B.Sc., F.I.C.E., F.I.Mun.E., F.R.T.P.I., M.I.H.E, F.Ingt Arb.; c/o The Clerk and Chief Financial Officer, Town Hall, Caerleon.
