The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 3 (6) and 13 of the Import Duties Act 1958, viz.:

The Import Duties (Temporary Exemptions) (No. 9) Order 1973.

This Order, which implements obligations of the United Kingdom under the Treaty of Accession to the European Communities, provides for the temporary exemption from import duty, until 1st January 1974, of the goods listed in the Schedule if they satisfy the conditions to benefit from Regulation (EEC) 385/73 (which relates to goods entitled to benefit from the reduction of customs duties in trade between the United Kingdom and the other Member States of the European Communities).

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 3 (6) and 13 of the Import Duties Act 1958, viz.:

The Import Duties (Temporary Exemptions) (No. 11) Order 1973.

This Order provides that the goods listed in Schedule 1 shall be temporarily exempt from import duty, and those listed in Schedule 2 shall continue to be exempt from import duty, both until 1st January 1974, or, in the case of certain items, until such earlier day as is specified.

As regards the exemption for equipment for use in aircraft under heading 85.15, apparatus of a type approved by the Civil Aviation Authority is listed in Civil Aviation Publication CAP 208, Airborne Radio Apparatus Vol. 2, published by Her Majesty's Stationery Office. This publication is subject to amendment, and confirmation that apparatus is of a type approved at the date of this Order should be obtained from the Civil Aviation Authority, Controllerate of National Air Traffic Services, Tels. N2 (c), 19-29 Woburn Place, London, WC1H 0LX.

This Order provides that new potatoes shall be temporarily exempt from import duty until 2nd May 1973 and Old-crop potatoes shall be similarly exempt until 2nd June 1973.

THE SCHEDULE

The highways are situated at Newport, in the County of Monmouth.

The route of the main highway follows the route of the first stage of the Newport Inner Ring Road.

Lengths of Highway to be stopped up (all distances are approximate)

1. That length of Railway Street which extends from its junction with Depot Street in an easterly direction for a distance of 40 yards.

2. That length of Depot Street which extends from its junction with Railway Street in a southerly direction for a distance of 63 yards to its junction with Bridge Street.

3. That length of Exchange Road which extends from its junction with the private Railway owned access road in a south-westerly direction to a point 7 yards from its junction with Thomas Street for a distance of 62 yards.

4. That length of Thomas Street which extends from its north-western extremity in a south-easterly direction for a distance of 8 yards.

5. That length of Cambrian Road which extends from its junction with Station Approach in a southerly direction for a distance of 30 yards.

6. That length of highway, which is a footbridge, and which extends from Mill Street in a south-easterly direction for a distance of 72 yards to Station Approach.

7. That length of highway, which is a subway, and which extends from Mill Street in a south-easterly direction for a distance of 77 yards to Thomas Street.

TOWN AND COUNTRY PLANNING ACT 1971
