Squadron Leader Malcolm Anthony Pardoe Pugh (3134517), Royal Air Force.

On the 12th February 1973, during Exercise Sky Mist, Squadron Leader Pugh was briefed to fly as the number two of a pair of No. 1 Squadron Harriers, tasked with a simulated attack sortie in the Cairngorm Mountains. Returning from the mission, which was flown at high speed following difficult terrain at low level, he crested a ridge to find himself faced with a very large flock of birds that he could not avoid despite his immediate reaction. It felt as if several birds had struck his Harrier: the engine note changed and vibration began as the aircraft decelerated note changed and vioration began as the aircraft decelerated rapidly. He immediately diagnosed that at least one bird had been ingested by the engine, which had locked in surge and would not respond to the throttle. He shut down the engine and attempted an immediate relight using the emergency Manual Fuel Control System. He could not pull up to gain height because of a cloud layer above him which he did not wish to enter and add to his difficulties. which he did not wish to enter and add to his difficulties.

As he attempted the relight he transmitted a call to his As he attempted the relight he transmitted a call to his leader advising him of the emergency but, unfortunately, his leader simultaneously transmitted a call to change frequency and neither pilot heard the other. So far as Squadron Leader Pugh was concerned, therefore, he could not obtain any assistance in transmitting an emergency call. The engine did not relight and, although the aircraft was very close to the ground and was still decelerating rapidly, Squadron Leader Pugh coolly assessed the point of the ground abead as the point of tion chose a point on the ground ahead as the point at

which he would have to eject, informed his leader, shut down the engine once again and made a final attempt to relight. By now the speed was down to 270 knots. Having pressed the relight button for several seconds without any pressed the relight button for several seconds without any apparent effect, he reached his ejection point, abandoned the relight attempt and reached for his ejection seat firing handle. He called "ejecting" and was about to fire the seat when he heard the engine pick up. At this stage speed was decaying through 200 knots with the aircraft sinking rapidly towards a ridge. As the engine responded to a tentative throttle movement he immediately elected to stay with the aircraft and cleared the ridge by only a tunited the niverted in the internative to stay with the aircraft and cleared the ridge by only a hundred feet or so. He then diverted to Kinloss and made a safe fixed throttle landing. Faced with a most hazardous situation when his aircraft engine failed over hazardous situation when his aircraft engine failed over mountainous terrain with cloud above him, Squadron Leader Pugh would have been justified in ejecting almost immediately. As it was he went through a drill which involved a complete shut down of the engine on two occasions, during which time the aircraft was descending rapidly from a very low altitude. By remaining with his aircraft for so long Squadron Leader Pugh showed outstanding courage and devotion well beyond the normal call of duty. His cool assessment of the situation and deliberate decision to make a second attempt to relight the engine were in the make a second attempt to relight the engine were in the finest traditions of the Royal Air Force. By choosing to risk his life he undoubtedly saved a valuable aircraft and his example will remain an inspiration to all his fellow pilots.
