Highworth Rural District Council (County of Wilts) (Foot-path No. 1 Stratton St. Margaret) Public Path Extinguishment Order, 1973.

Notice is hereby given that the above-named Order, made on 11th July 1973, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed, as an unopposed Order, by the Highworth Rural District Council.

The Guildford Rural District Council (Right of Way No. 65 Send) Public Path Diversion Order, 1973

Notice is hereby given that the above-named Order, made on the 4th July 1973 is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order, by the Guildford Rural District Council.
