Part II

Amendment of Articles of the 1964 Order

1. In Article 15 (severe disablement occupational allowance) the words "or would be in receipt of such an allowance if he were not in a hospital or other institution," shall be omitted, and there shall be added to the Article the words "other than injury benefit or sickness benefit.".

2. For paragraph (4) of Article 17 (unemployability allowances) there shall be substituted the following paragraph:—

"(4) Where a member is awarded an allowance under paragraph (1)(i) of this Article, he may also be awarded additional allowances for dependants in accordance with the following provisions of this paragraph—
