TOWN AND COUNTRY PLANNING ACT, 1971

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 209 of the Town and Country Planning Act, 1971, to authorise the stopping up of that length of footpath on the western side of Wyndham Street at Bridgend in the County of Glamorgan which extends from its junction with Dunraven Place in a northerly direction for a distance of approximately 43 yards to enable re-development to be carried out in accordance with a planning permission granted by Glamorgan County Council under Part III of that Act.

During 28 days from the 5th September 1973, copies of the draft Order and relevant plan may be inspected at all reasonable hours at the offices of the Bridgend Urban District Council, Bridgend and may be obtained free of charge from the Secretary of State (quoting Reference R15/296/3) at the address stated below.
