pursuit continued until the next road junction where Mak fired a third shot at Mr. O'Brien but missed.

Mr. O'Brien then jumped on Mak and they struggled.

Mr. Reid rushed across the road and seized Mak's right hand, in which the gun was held, pointing at Mr. O'Brien's head, and forced Mak to release the gun. All three fell to the ground where Mak slashed Mr. Reid's left hand with his knife. The struggle went on until they were assisted by a uniformed Police Constable.

Both Inspectors whilst unarmed showed the highest degree

of courage in tackling and arresting an armed and danger-ous man, in complete disregard for their own safety. These officers displayed bravery and initiative of a very

high order.
