

# DEPARTMENT OF EMPLOYMENT

### **FACTORIES ACT 1961**

Draft Construction (Health and Welfare) (Amendment) Regulations

- 1. In pursuance of section 180 of, and Schedule 4 to, the Factories Act 1961, the Secretary of State for Employment hereby gives notice that he proposes to make regulations amending Regulations 3 (2) and 8 of the Construction (Health and Welfare) Regulations 1966. These amendments are consequent on the reorganisation of the health services, in particular the provision of ambulance services, under the National Health Service (Reorganisation) Act 1973, and the National Health Service (Scotland) Act 1972.
- 2. Regulation 8 of the Construction (Health and Welfare) Regulations 1966 requires a contractor in specified circumstances to notify the local health authority of the location of his site, the nature of the operations or works and certain other matters and to obtain from the local health authority the address of the nearest hospital named by that authority as one designated by the Regional Hospital Board to provide accident and emergency services. The proposed regulations will amend these requirements so as to substitute for the references to the local health authority and the Regional Hospital Board references to the appropriate successors under the said Acts of 1972 and 1973.
- 3. Copies of the draft amending regulations which are entitled "Draft Construction (Health and Welfare) (Amendment) Regulations" may be obtained from H.M. Stationery Offices at the addresses shown on the last page of this Gazette or through any bookseller.
- 4. Any objection with respect to the draft regulations by or on behalf of persons affected must be sent to the Secretary of State on or before 17th November 1973.

Every objection must be in writing and state:

(a) the specific grounds of objection; and
