Imposition of 40 m.p.h. Speed Limit

Notice is hereby given that the Secretary of State for Wales has made an Order under section 74 (1) and section 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, prohibiting the driving
