On 30th June 1973, whilst H.M.S. HIGHBURTON was stationed at Kyle of Lochalsh, the following incident occurred when a rating with a loaded pistol threatened his Commanding Officer and the Officer of the Day in the Wardroom flat. The rating also fired the pistol into a wooden door proving that it was loaded.

Leading Seaman CARR, who was in the Mess at the time, went to the Wardroom on hearing the shot. Without hesitation he approached the rating although the gun was pointing directly at him. He tried reasoning with the rating but on his refusal to surrender the pistol Leading Seaman

CARR proceeded to disarm him.

Leading Seaman CARR's great courage and decisiveness in a highly dangerous situation were in the best traditions of the Service.
