ROYAL LICENCE

ROYAL WARRANT OF PRECEDENCE

The QUEEN has been graciously pleased to ordain and declare that Michael Albemarle Bowes-Lyon, Gentleman, and Mary Cecilia wife of Timothy James Alan Colman, Gentleman, and Patricia Maud formerly wife of Oliver Robin Tetley, Gentleman, may henceforth have, hold and enjoy the same title, rank, place, pre-eminence and precedence as the son and daughters of an Earl which would have been due to them had their father The Honourable Michael Claude Hamilton Bowes-Lyon survived his nephew Timothy Patrick Earl of Strathmore and Kinghorne and thereby succeeded to the title and dignity of Earl of Strathmore and Kinghorne.

And to command that the said Royal Concession and Declaration be recorded in Her Majesty's College of Arms and in Her Majesty's Lyon Office in Edinburgh.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 1 (4), (5) and (6) of the Finance Act 1973 viz.: The Customs Duties and Drawbacks (Revenue Duties) (Morocco) Order 1974.

1. This Order, which comes into effect on 1st March 1974, implements the obligations of the United Kingdom under the agreement of 2nd March 1973, between the enlarged E.E.C. and Morocco. It provides for the reduction of the protective elements in the customs revenue duties on certain goods to the rates applicable to imports from E.E.C. countries. The goods are certain spirits, beer, vermouth, manufactured tobacco, matches and mechanical lighters.

2. The Order also revokes, for all revenue duty goods, other than hydrocarbon oils, originating in Morocco, the arrangements introduced in the Customs Duties and Drawbacks (Revenue, including Hydrocarbon Oil, Duties) (Miscellaneous Amendments) Order 1973 (S.I. 1973/2085), under which increases in duties were suspended pending the entry into force of this agreement. The effect of this is to apply the full rates of duty, imposed by the Customs Duties and Drawbacks (Revenue Duties) Order 1973 (S.I. 1973/1946), to fermented beverages (other than wine), certain industrial spirits obtained from agricultural products, wine lees and unmanufactured tobacco.

3. The Order provides for like adjustments in the drawback rates where applicable.
