The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 1, 3 (6) and 13 of the Import Duties Act 1958 as amended viz.: The Import Duties (Temporary Reductions and Exemptions) (No. 2) Order 1974. This Order provides for exemption from or reductions in import duty in the case of goods specified in the Schedules from 1st March 1974 to 31st December 1974 or in the case of certain goods to the earlier dates there specified

specified.

There is exemption from import duties in the case of all goods in Schedules 1 and 2 if the goods satisfy the requisite conditions to benefit from the eventual abolition of customs duties in trade between Member States of the European Communities.

In the case of other goods, where a rate of duty is specified in column 3 of Schedule 1 or 2 duty is reduced to that rate instead of any higher rate which would other-wise apply and where "free" appears in column 3 in relation to the goods, they are exempt from duty whatever their origin.

In the case of goods originating in Egypt or Cyprus greater reductions in duty are available than those referred to above in a number of cases, such reductions being shown respectively in columns 4 and 5 of Schedules 1 and 2. Goods of a description specified in Schedule 2 have

hitherto been subject to reductions in import duty which are extended by this Order.

As regards the exemption for equipment for use in aircraft under heading 85.15, apparatus of a type approved by the Civil Aviation Authority is listed in Civil Aviation Publica-tion CAP 208, Airborne Radio Apparatus Volumn 2, pub-lished by Her Majasty's Stationery Office. This publication issued by Her Majesty's Stationery Office. This publication is subject to amendment, and confirmation that apparatus is of a type approved at the date of this Order should be obtained from the Civil Aviation Authority, Controllerate of National Air Traffic Services, Tels N2(c), 19-29 Woburn Place, London, WC1H 0LX. The Order (Article 6) also makes some minor corrections to the Import Duties (Temporary Reductions and Exemp-tions) (No. 3) and (No. 4) Orders 1973. The Order comes into operation on 1st March 1074
