- Duxons Turn Shopping Service Road, east side for whole length.
- Duxons Turn, northern section on the north side from Maylands Avenue to the west side of No. 5 Duxons Turn.
- Duxons Turn, northern section on the south side from the kerb line of Maylands Avenue for a distance of 33 yards westwards thereof.
