NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1971, SECTION 210

Gloucester County Council (DMD41 Mitcheldean) Public Path Diversion Order, 1973

Notice is hereby given that on the 22nd February 1974 the Gloucestershire County Council confirmed the above-named Order the effect of which is to extinguish that length of footpath DMD41 in the Parish of Mitcheldean from its junction with the south-east end of Maymeadow Lane extending south-westwards for 75 metres and south-eastwards for 165 metres, around Mitcheldean Primary School, to a point 68 metres north-west of the junction of footpath DMD41 with Silver Street and the A.4136 near Mitcheldean Congregational Church. An alternative highway in lieu will be created over a 2 metres wide strip of land from a point on Maymeadow Lane 64 metres south-east of its junction with New Street extending south-westwards for 114 metres, south south-eastwards for 212 metres and north-eastwards for 36 metres to reconnect with footpath DMD41 at a point 68 metres north-west of its junction with Silver Street and the A.4136.

A copy of the Order and map contained in it has been deposited at the offices of the East Dean Rural District Council, Cinderford and may be inspected free of charge between the hours of 9 a.m.—1 p.m. and 2 p.m.—4 p.m. Mondays to Fridays inclusive.
