### ROYAL LICENCE

Whitehall, London S.W.1.  
16th April 1974.

The QUEEN by Royal Warrant bearing date the 16th day of April 1974 has been graciously pleased to give and grant Her Majesty's Royal Licence and Authority that the Arms and Crest of Massingberd may be taken and assumed and borne and used by William Massingberd, Gentleman, and Thomas Massingberd, Gentleman, residing in Helsinki, Finland, and by their issue, the whole according to the Laws of Arms, the said Armorial Bearings being first duly exemplified according to the Laws of Arms and recorded in Her Majesty's College of Arms otherwise Her Majesty's said Royal Licence and Permission to be void and of none effect.

And to command that the said Royal Concession and Declaration be recorded in the College of Arms.
