### TREASURY

Treasury Chambers London S.W.1.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 1, 2, 3 (6) and 13 of the Import Duties Act 1958 viz: The Import Duties (Temporary Reductions and Exemptions) (No. 6) Order 1974.

This Order provides for exemption from or reduction in import duty in the case of goods specified in Schedules 1 and 4 to the Order from 3rd May 1974 and in the case of goods specified in the other Schedules from 1st June 1974 until the dates appearing in the Schedules.

There is exemption from import duties in the case of all goods, in Schedules 1, 2 or 4 if the goods satisfy the requisite conditions to benefit from the eventual abolition of
