## THE PUBLIC SCHOOLS ACT 1868

THE GOVERNING BODY OF HARROW SCHOOL, having, on the 30th day of May 1974, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto altering clauses 1 and 3 of the Statute of the School dated the 16th day of May 1871, the said Statute is hereby published in the *London Gazette* in accordance with the provisions in that behalf contained in the said Act.

And Notice is hereby given, that any person, body of persons or body corporate, authorised in that behalf by the said Act, may within two months after the publication of this notification petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statute.

STATUTE made by the Governing Body of Harrow School on the 30th day of May 1974

A STATUTE for altering clauses 1 and 3 of the Statute of the Sixteenth day of May One thousand eight hundred and seventy-one then made for determining and establishing the Constitution of the then New Governing Body of Harrow School by the Special Commissioners appointed for the purposes of the Public Schools Act 1868.

WHEREAS by section 11 of the Public Schools Act 1868 it is enacted that any Statute made in exercise of the powers of that Act may at any time or times after the expiration of the powers of that Act conferred upon the Special Commissioners be repealed or altered by the Governing Body for the time being in the same manner and subject to the same provisions with the exception of those requiring such Statutes to be submitted to and approved by the Special Commissioners in and subject to which Statutes may be made by the Governing Body.

AND WHEREAS by clause 1 of the said Statute of the Sixteenth day of May One thousand eight hundred and seventy-one as altered by a Statute of the Governing Body of Harrow School sealed on the Fourteenth day of April One thousand nine hundred and thirty-nine and approved by His Majesty in Council on the Third day of July One thousand nine hundred and thirty-nine it is provided as follows:

"1. The Governing Body of Harrow School shall consist of the following members namely:

"One member to be elected by the Hebdomadal Council of the University of Oxford

"One member to be elected by the Council of the Senate of the University of Cambridge

"One member to be elected by the President and Council of the Royal Society

"One member to be elected by the Lord Chancellor for the time being

"One member to be elected by the Head Lower and Assistant Masters of the School for the time being

"Ten members to be elected by the Keepers and Governors of the possessions revenues and goods of the Free Grammar School of John Lyon within the town of Harrow-on-the-Hill in the County of Middlesex for the time being PROVIDED that each of the members elected or to be elected by the Keepers and Governors of the possessions revenues and goods of the Free Grammar School of John Lyon within the town of Harrow-on-the-Hill in the County of Middlesex for the time being shall be elected for a period of five years only but shall thereafter from time to time be eligible for re-election".

AND WHEREAS by clause 3 of the said Statute of the Sixteenth day of May One thousand eight hundred and seventy-one it is provided that every vacancy occurring in the offices of members of the Governing Body shall be filled up within three months after the date of its occurrence in the manner thereafter more particularly mentioned

Now Ws the Keepers and Governors of the possessions revenues and goods of the Free Grammar School of John Lyon within the town of Harrow-on-the-Hill in the County of Middlesex (hereinafter called "the Keepers and Governors of Harrow School") being the Governing Body of Harrow School for the time being being desirous of altering clauses 1 and 3 of the said Statute of the Sixteenth day of May One thousand eight hundred and seventy-one in pursuance of the said section 11 of the said Public Schools Act 1868 and any and every other power us hereunto enabling do by this Statute enact as follows:

1. The Governing Body of Harrow School shall consist of the following members namely:

Fifteen members to be elected respectively as mentioned in clause 1 of the said Statute of the Sixteenth

day of May One thousand eight hundred and seventy-one as altered by the said Statute of the Governing Body of Harrow School sealed on the Fourteenth day of April One thousand nine hundred and thirty-nine and

Such further and additional members as from time to time shall be elected by the Keepers and Governors of Harrow School for the time being but so that the total number of members of the said Governing Body shall not at any time exceed twenty PROVIDED that each of such further and additional members to be elected by the Keepers and Governors of Harrow School for the time being after the date when this Statute comes into force shall (in like manner to the other ten members elected by the Keepers and Governors of Harrow School) be elected for a period of five years only but shall thereafter from time to time be eligible for re-election

2. Notwithstanding the provisions of clause 3 of the said Statute of the Sixteenth day of May One thousand eight hundred and seventy-one it shall not be obligatory upon the Governing Body to ensure the election of the further or additional members hereinbefore referred to in clause 1 of this Statute within three months of the date when this Statute comes into force nor to fill up every vacancy occurring in the offices of those members of the Governing Body who are elected by the Keepers and Governors of Harrow School for the time being within three months after the date of its occurrence so long as there shall be at the date of the occurrence of such vacancy not less than ten members of the Governing Body elected by the Keepers and Governors of Harrow School

### MOTORWAY SERVICE AREAS

#### *Tenders invited for Hensall Service Area on M62*

The Secretary of State for the Environment invites applications for the right to build and operate petrol filling stations and single storey catering establishments on a 50 year ground lease, at Hensall near Knottingley, Yorkshire, on the Lancashire-Yorkshire motorway (M62).

Sites on opposite sides of the motorway, totalling about 40 acres (16.2 hectares) are to be developed as one Service Area.
