

(b) to construct a new highway to connect Bridleway No. 97 with the Newtown-Aberystwyth Trunk Road; and

(c) to stop up a length of the private means of access from the superseded trunk road to premises known as Bontnewydd Farm

all at Morfodion Bridge aforesaid and providing for the transfer of the said new highway mentioned in 2 (b) above to the County Council of Powys as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the Orders and of the relevant plans have been deposited at the Welsh Office, Cathays Park, Cardiff, and at the offices of Powys County Council, County Hall, Llandrindod Wells, Powys, where they are open to inspection free of charge at all reasonable hours.

Any person aggrieved by the Orders and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959 or the Highways Act 1971 or on the ground that any requirement of either of those Acts, or of regulations made thereunder, has not been complied with in relation to the Orders, may within 6 weeks from 4th October 1974, apply to the High Court for the suspension or quashing of the Orders or of any provision contained therein.
