Notice is hereby given that the above Order made on the 31st July 1974, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order by the Council of the Borough of Harrogate.

The effect of the Order, if confirmed without modification, will be to divert the public right of way in respect of that part of public footpath No. 7 in the Parish of North Stainley running from the A.6108 Ripon to Masham Road at a point 8 yards north of the Telephone Exchange boundary (map reference 286 769) in a north-westerly direction across field 351 for a distance of 182 yards to a point 2 yards north of the south-westerly boundary of Shop Wood Field No. 454 (map reference 285 769.5) to a line running from the A.6108 Ripon to Masham Road at a point 74 yards north of the Telephone Exchange boundary namely at a point being map reference 286 769.5 in a generally westerly direction along the footway of a proposed access road for a distance of 157 yards between points A-B (on the map annexed to the Order) and thence in a generally south-westerly direction between building plots C and D (shown on the said plan) for a distance of 62 yards to a point joining the existing path at map reference 285 769.5.
