He was hospitalised for 10 days and subsequently received 28 days sick leave.

Without hesitation and upon his own initiative, Detective Constable LAU Piu placed himself between the attacking gang and their proposed victims in circumstances in which his own life was patently placed in danger. His conduct prevented the commission of a violent crime and safeguarded the intended victims from serious injuries and possibly death. In addition, he effected the arrest of one of the offenders notwithstanding the odds against him and the injuries he received.

Detective Constable LAU Piu acted with complete disregard for his personal safety and displayed courage and determination of purpose of the highest order in dangerous

circumstances.
