

Parish of Baddesley Clinton which at present extends immediately south-east of Badgers Wood plantation at the boundary between fields parcels 1871 and 3384; thence north-eastwards across fields parcels 3384 and 3600 to its junction with Haywood Lane, a total distance of 235.5 metres or thereabouts to a new line extending from a point immediately north-east of Badgers Wood plantation in a north-westerly direction for 18 metres through the tree belt; thence north-eastwards for a distance of 250 metres following the south-easterly boundaries of fields parcels 0007 and 3624 to its junction with Haywood Lane.

Warwick District Council Extinguishment of Parts of Footpaths W.136 and W.136a (Cubbington) Order, 1974

Notice is hereby given that the above-named Order made on 12th December 1974 is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed as an unopposed Order, by the Warwick District Council.

The effect of the Order, if confirmed without modification, will be to extinguish parts of the public rights of way No'd. W.136 and W.136a at Cubbington, Warwickshire. The part of Footpath W.136 to be extinguished is that part running southwards from the rear of the Village Hall, Cubbington, to the junction of Broadway and Ledbrook Road, Cubbington, being 180 metres in length. The part of Footpath W.136a to be extinguished is the part extending westwards from its junction with Broadway, Cubbington, to its junction with Footpath W.136, a distance of 34 metres.

Warwick District Council Diversion of Footpath W.179d (Leek Wootton) Order, 1974

Notice is hereby given that the above-named Order made on 12th December 1974 is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed as an unopposed Order, by the Warwick District Council.

The effect of the Order, if confirmed without modification, will be to divert part of the public right of way No. W.179d at Leek Wootton, Warwickshire, which at present crosses the garden of the property known as "Upper Woodloes" from east to west for a distance of 81 metres and thence in a south south-westerly direction for a distance of 69.5 metres where it joins Footpath W.179 to a new line skirting the western boundary of field parcel 30A in a southerly and south-easterly direction for a distance of 66.5 metres and then immediately alongside the southern boundary of the properties at present known as "Toad Hall" and "Misty Ridge" from east to west for a distance of 114.5 metres, at which point it will join Footpath W.179.
