## The QUBEN's Most Excellent Majesty in Council

Whereas it is expedient to provide for the increase of certain pensions granted in respect of service in Her Majesty's Naval and Marine Forces to correspond, as nearly as may be, with the benefits provided, in the case of civil pensions, by the Pensions (Increase) Act 1971 (1971 c. 56), as amended by the Superannuation Act 1972 (1972 c. 11). Now, therefore, Her Majesty, in exercise of the powers conferred upon Her by section 3 of the Naval and Marine Pay and Pensions Act 1865 (1865 c. 73), and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered. as follows: Whereas it is expedient to provide for the increase of certain

### Citation

1. This Order may be cited as the Naval and Marine Pay and Pensions (Pensions Increase) (No. 1) Order 1974.

Interpretation

2. The Interpretation Act 1889 (1889 c. 63) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

#### General

3. The provisions contained in the Schedule to this Order shall have effect from 1st December 1973.
